

MEMORANDUM OF LAND SALE AGREEMENT


Lot 80, Block 4, Klamath Forest Estates, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

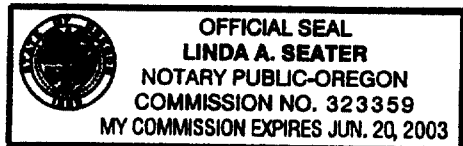
