OF MORTGAGE, as follows:


That certain mortgage dated the 26th day of August, 1997, by EDGAR L. VIETS

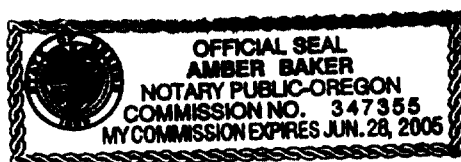
