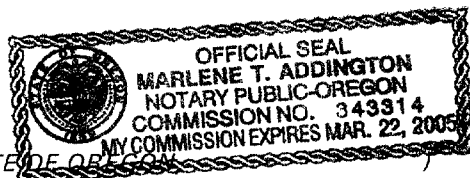
The undersigned, RONALD J. BLODGETT and MARY JANE BLODGETT, husband and wife
