For value received Klamath County, a political subdivision of the State of Oregon (Grantor) hereby grants to Qwest Corporation, a Colorado Corporation, it's successors and assigns (Grantee), a 10 foot wide perpetual non-exclusive easement, for the construction, reconstruction, operation, and maintenance of it's facilities on the real property of the Grantor, situated in the NW¼ of Section 35, Township 38 South, Range 9 East, W. M., Klamath County, Oregon, being a portion of Parcel 3 of Land Partition 60-97 filed in the Klamath County Clerk's office and being more particularly described as follows:

Commencing at the ¼ corner common to Sections 34 and 35 of said Township 38 South, Range 9 East W. M.; thence S 89°35′44″ E - 1378.20 feet along the South right of way line of Upland Way to a point; thence N 00° 13′34″ E - 29.83 feet to a point on the North right of way line of said Upland Way at the intersection with the centerline of vacated Sears Way, said point also being the true point of beginning; thence S 89° 35′ 44″ E - 1330.30 feet along said North right of way line of Upland Way to a point at the intersection with the North-South center section line of said Section 35; thence N 00° 15′ 35″ E - 10.00 feet along said North-South center section line to a point; thence N 89° 35′ 44″ W - 1330.30 feet to a point on the centerline of said vacated Sears Way; thence S 00° 13′ 34″ W - 10.00 feet to the point of beginning. Bearings and distances for this description are based on Survey #6887 on file in the Klamath County Surveyor's office.

Grantor further conveys to Grantee the right of ingress and egress to and from the Easement area during all periods of construction, reconstruction, operation and maintenance over and across Grantor's lands with the right to clear and keep cleared all trees and other obstructions as may be necessary for Grantee's use and enjoyment of the Easement area.

Grantor reserves the right to occupy, use and cultivate the Easement area for all purposes not inconsistent with the rights therein granted.

Grantor hereby covenants that no excavation, structure or obstruction will be constructed, or permitted on the Easement area and no change will be made, by granting or otherwise, that would adversely affect Grantee's use and enjoyment of the Easement area.

The rights, conditions and provisions of this Agreement shall run with the land and shall mure to the benefit of and be binding upon Grantor and Grantee and their respective successors and assigns; and this Easement shall terminate if and when Grantee shall have abandoned all use of the right of way and no longer has any future need therefor.


