

MEMORANDUM OF LAND SALE AGREEMENT

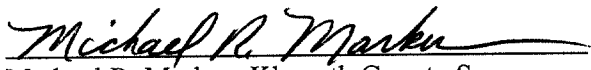

In Witness Whereof the said vendor has executed this Memorandum June 30, 2003.

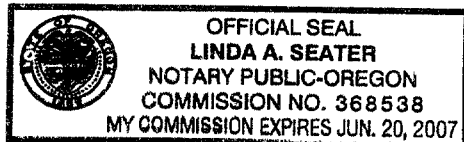
