TRUSTEE'S DEED

THIS INDENTURE, Made this 7th day of July, 2003, between AMERITITLE, hereinafter called trustee, and FRANK POZAR and ELEANOR POZAR hereinafter called the second party;

WITNESSETH:

RECITALS: ABUNDANT HARVEST FARMS, INC., a Nevada corporation, as grantor executed and delivered to AmeriTitle, as trustee, for the benefit of KENCO INVESTMENTS, INC., a California corporation, as beneficiary, a certain trust deed dated October 11, 2000 and duly recorded on October 13, 2000, in Volume M00 at Page 37493, Deed Records of Klamath County, Oregon. The undersigned trustee on July 3, 2003, at the hour of 10:00 o'clock, A.M. in accord with the standard of time established by ORS 187.110, and at the place so fixed for sale, in full accordance with the laws of the State of Oregon and pursuant to the powers conferred upon the trustee by the trust deed, sold the real property in one parcel at public auction to the second party for the sum of \$426,344.70, the second party being the highest and best bidder at the sale and that sum being the highest and best bid for the property.
