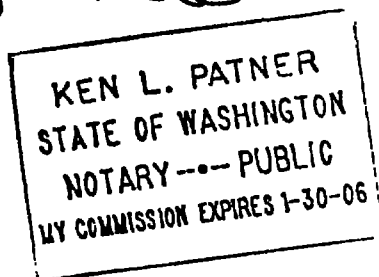

## AMENDED TRUSTEE'S NOTICE OF SALE

Reference is made to that certain trust deed made by Patrick T. Brooks, as grantor, to Amerititle, as trustee, in favor of Columbia River Bank Mortgage Group, as beneficiary, dated 02/09/00, recorded 02/16/00, in the mortgage records of Klamath County, Oregon, in Volume M00, Page 4926, covering the following described real property situated in said county and state, to wit:


