

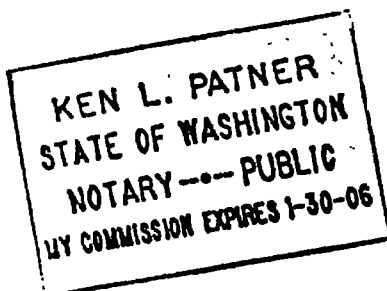



Brooks, as grantor, to Amerititle, as trustee, in favor of Columbia River Bank Mortgage Group, as beneficiary, dated 03/03/00, recorded 03/10/00, in the mortgage records of Klamath County, Oregon, in Volume M00, Page 7837, covering the following described real property situated in said county and state, to wit:


