## **TRUST DEED**

THIS TRUST DEED, made this 26th day of July, 2003 between Barry D. Glasser and Mary K. Glasser Tenants by Entirety, as Grantor, AmeriTitie, as Trustee, and Running Y Resort, Inc., an Oregon corporation, as Beneficiary,

## WITNESSETH:
