SUPPLEMENTAL MEMORANDUM OF LEASE

THIS SUPPLEMENTAL MEMORANDUM OF LEASE ("Memorandum") is made and entered into as of the 15th day of August, 2003, by and between COLLINS PRODUCTS LLC. an Oregon limited liability company ("Lessor"), and KLAMATH ENERGY LLC, an Oregon limited liability company ("Lessor").

RECITALS

- A. Lessor and Lessee's predecessor in interest, PacifiCorp Power Marketing, Inc., an Oregon corporation now known as PPM Energy, Inc. ("PPM"), entered into that certain Lease dated May 1, 2001 (the "Lease"), a Memorandum of which was recorded on August 29, 2001, in Vol. M01. Page 44032 of the official records of Klamath County, Oregon. Capitalized terms used in this Memorandum and not otherwise defined have the same meanings ascribed to such terms in the Lease.
- B. PPM assigned all of its right, title and interest as lessee in, to and under the Lease to Lessee by that certain Assignment and Assumption of Lease Agreement dated May 15, 2002, recorded on May 17, 2002, in Vol. M02, Page 29622 of the official records of Klamath County, Oregon.
- C. Lessor and Lessee now wish to memorialize of record the initial expiration date of the Term of the Lease and the dates of the extension terms, as contemplated in Sections 4.2 and 4.3 of the Lease, as provided in this Memorandum.
