The true and actual consideration for this conveyance is \$75,000.00.

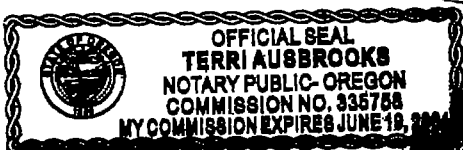
