TRUSTEE'S DEED

THIS INDENTURE, Made this 29th day of September, 2003, between Richard L. Biggs, hereinafter called trustee, and CitiFinancial, Inc., hereinafter called the second party;

RECITALS: Sonja L. Maricle, as grantor, executed and delivered to Aspen Title and Escrow, Inc. as trustee, for the benefit of Associates Financial Services Company of Oregon, Inc. The trustee published a copy of the notice of sale in a newspaper of general circulation in each county in which the real property is situated once a week for four successive weeks. The last publication of the notice occurred more than twenty days prior to the date of sale. The mailing, service and publication of the notice of sale are shown by affidavits and/or proofs of service duly recorded prior to the date of sale in the county records, those affidavits and proofs, together with the Notice of Default and Election to Sell and the notice of sale, being now referred to and incorporated in and made a part of this deed as if fully set forth herein. The undersigned trustee has no actual notice of any person, other than the persons named in those affidavits and proofs as having or claiming a lien on or interest in the real property, entitled to notice pursuant to ORS 86.740(1)(b) or (1)(c).

The true and actual consideration for this conveyance is \$21,4000.00.
