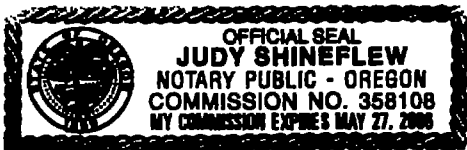

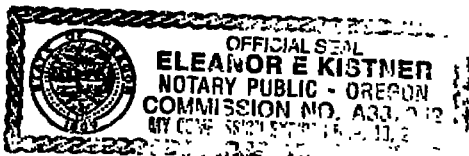
**DEED OF FULL RECONVEYANCE**
