TRUSTEE'S DEED

THIS INDENTURE, Made this date, November 4, 2003, between Glenn H. Prohaska, hereinafter called trustee, and Green Tree Servicing, LLC, hereinafter called the second party; WITNESSETH:

RECITALS: Dave W. Deloyola and Loretta Towell, as grantor, executed and delivered to Nancy L. Peterson as trustee, for the benefit of Conseco Finance Servicing Corp. (fka Green Tree Financial Servicing Corporation), as beneficiary, a certain trust deed dated December 11, 1997, recorded December 18, 1997 in the Records of Klamath County, Oregon, Recording No./Fee No./ Vol. M97, Page 41066, Document No. 50294. If the foreclosure proceedings were stayed and released from the stay, copies of an amended notice of sale in the form required by ORS 86.755 (6) were mailed by registered or certified mail to the last known addresses of those persons listed in ORS 86.740 and 86.750 (1) and to the address provided by each person who was present at the time and place set for the sale which was stayed within 30 days after the release from the stay. The trustee published a copy of the notice of sale in a newspaper of general circulation in each county in which the real property is situated once a week for four successive weeks. The last publication of the notice occurred more than twenty days prior to the date of sale. The mailing, service and publication of the notice of sale are shown by affidavits and/or proofs of service duly recorded prior to the date of sale in the county records, those affidavits and proofs, together with the Notice of Default and Election to Sell and the notice of sale, being now referred to and incorporated in and made a part of this deed as if fully set forth herein. The undersigned trustee has no actual notice of any person, other than the persons named in those affidavits and proofs as having or claiming a lien on or interest in the real property, entitled to notice pursuant to ORS 86.740 (1)(b) or (1)(c).

The undersigned trustee, on November 4, 2003, at the hour of 11:00 o'clock A.M., in accord with the standard of time established by ORS 187.110, which was the day and hour to which the sale was postponed as permitted by ORS 86.755 (2), or when applicable,
