DEED OF RECONVEYANCE

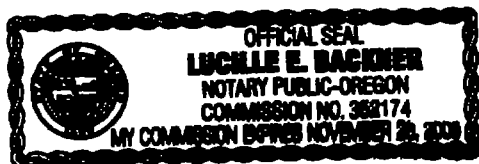
