ASSIGNMENT OF TRUST DEED

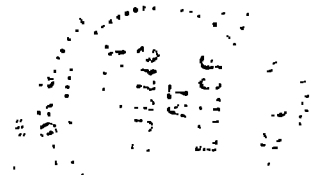
