In the Matter of dedicating a 40-foot strip of land at the Klamath County Youth Sports Park as City of Klamath Falls road right-of-way

## **UPLAND WAY DESCRIPTION**

A forty (40) foot strip of land situated in the SW1/4 of Section 35, Township 38 South, Range 9 East, W.M., Klamath County, Oregon, for road purposes and being a portion of Parcel 3 of Land Partition 60-97 and Property Line Adjustment 9-02 filed in the Klamath County Surveyor's Office and being more particularly described as follows:

Commencing at the ¼ corner common to Sections 34 and 35 of said Township 38 South, Range 9 East W.M.; thence S 89° 35' 44" E – 1016.50 feet along the south right of way line of Upland Way to a 5/8" iron pin marking the true point of beginning of this description; thence continuing S 89° 35' 44" E – 1691.98 feet along said south right of way line of Upland Way to a point at the intersection with the north-south center section line of said Section 35; thence S 00° 15' 35" W – 40.00 feet along said north-south center section line to a point; thence N 89° 35' 44" W – 1692.16 feet to a point on the adjusted property line as per said Property Line Adjustment 9-02; thence N 00° 30' 40" E – 40.00 feet along said adjusted property line to the point of beginning. Bearings and distances for this description are based on Survey #6887 on file in the Klamath County Surveyor's Office.
