TRUSTEE'S DEED

THIS INDENTURE, Made this date, November 14, 2003, between Glenn H. Prohaska, hereinafter called trustee, and Green Tree Servicing, LLC, hereinafter called the second party; WITNESSETH:

RECITALS: John W. Brown and Autumn R. Clopp, as grantor, executed and delivered to Nancy L. Peterson as trustee, for the benefit of Conseco Finance Servicing Corp. (fka Green Tree Financial Servicing Corporation), as beneficiary, a certain trust deed dated November 13, 1998, recorded November 18, 1998 in the Records of Klamath County, Oregon, Recording No/Fee No/Vol. M98, Page 42263, Doc. No. 70038. In that trust deed, the real property therein and hereinafter described was conveyed by the grantor to the trustee to secure, among other things, the performance of certain obligations of the grantor to the beneficiary. The grantor thereafter defaulted in performance of the obligations secured by the trust deed as stated in the notice of default hereinafter mentioned, and such default still existed at the time of the sale hereinafter described.

Copies of the notice of sale were served upon occupants of the property described in the trust deed in the manner in which a summons is served pursuant to ORCP 7 D. (2) and 7 D. (3) at least 120 days before the date the property was sold, pursuant to ORS 86.750 (1). If the foreclosure proceedings were stayed and released from the stay, copies of an amended notice of sale in the form required by ORS 86.755 (6) were mailed by registered or certified mail to the last known addresses of those persons listed in ORS 86.740 and 86.750 (1) and to the address provided by each person who was present at the time and place set for the sale which was stayed within 30 days after the release from the stay. The trustee published a copy of the notice of sale in a newspaper of general circulation in each county in which the real property is situated once a week for four successive weeks. The last publication of the notice occurred more than twenty days prior to the date of sale. The mailing, service and publication of the notice of sale are shown by affidavits and/or proofs of service duly recorded prior to the date of sale in the county records, those affidavits and proofs, together with the Notice of Default and Election to Sell and the notice of sale, being now referred to and incorporated in and made a part of this deed as if fully set forth herein. The undersigned trustee has no actual notice of any person, other than the persons named in those affidavits and proofs as having or claiming a lien on or interest in the real property, entitled to notice pursuant to ORS 86.740 (1)(b) or (1)(c).

The undersigned trustee, on November 14, 2003, at the hour of 10:00 o'clock A.M., in accord with the standard of time established by ORS 187.110, which was the day and hour to which the sale was postponed as permitted by ORS 86.755 (2), or when applicable,

which was the day and hour set in the amended notice of sale) and at the place so fixed for sale, in full accordance with the laws of the State of Oregon and pursuant to the powers conferred upon the trustee by the trust deed, sold the real property in one parcel at public suction to the second party for the sum of \$ 54,466 the second party being the highest and best bidder at the sale, and that sum being the highest and best bid for the property.
