## **AERIAL COMMUNICATIONS LINE RIGHT-OF-WAY EASEMENT**

situated in the County of Klamath, State of Oregon, together with such additional area as may be reasonably required for placement and maintenance of down guys and anchors supporting the Company's aerial facilities placed hereunder. It is the intent of this easement grant that the Company's aerial cable facilities will be attached only to existing power utility poles, or replacements thereof. It is agreed that the Company, its successors and assigns, shall have access to said premises for the purposes stated, and shall be responsible for any damage to said premises by reason of any negligence on the part of said Company's employees while placing and maintaining construction. Said property shall be restored, as nearly as reasonably possible, to prior or better condition in a workmanlike manner.
