WARRANTY DEED - SURVIVORSHIP

KNOW ALL BY THESE PRESENTS that MURELLA R. ALBERT

hereinafter called grantor, for the consideration hereinafter stated, to grantor paid by MURELLA R. ALBERT and RANDY R. ALBERT, Not as tenants in common, but with full rights of survivorship, hereinafter called grantees, does hereby grant, bargain, sell and convey unto the grantees, not as tenants in common but with the right of survivorship, their assigns and the heirs of the survivor of the grantees, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

That portion of the S 1/2, S 1/2, SE 1/4 in Section 25, Township 34 South, Range 8 East of the Willamette Meridian, lying West of the Sprague River, Klamath County, Oregon.

SUBJECT TO: An easement for a 30 foot irrigation ditch which shall not exceed 5 feet of water width.

FURTHER SUBJECT TO: Reservations, restrictions and/or rights-of-way of record and those apparent on the land.

(IF SPACE INSUFFICIENT, CONTINUE DESCRIPTION ON REVERSE SIDE)

To Have and to Hold the same unto grantees, their assigns and the heirs of such survivor, forever; provided that grantees herein do not take the title in common but with the right of survivorship, that is, that the fee shall vest absolutely in the survivor of the grantees.

And grantor hereby covenants to and with grantees, their assigns, and the heirs of such survivor, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except (if no exceptions, so state): except as stated hereinabove.

grantor will warrant and forever defend the premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
