This power shall take effect (delete inapplicable phrase):

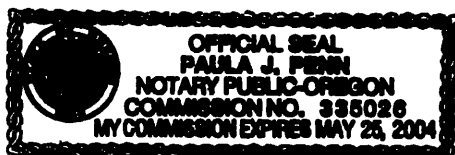
(a) on the date next written below;
