or Book M01 Page 61223' recorded on 11/30/2001 .

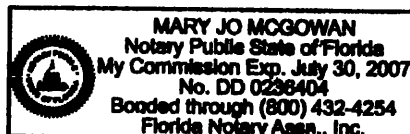
