- 5) A copy of the recorded exemption application (this form) must be received by DMV within 30 days of the date of recording with the county.

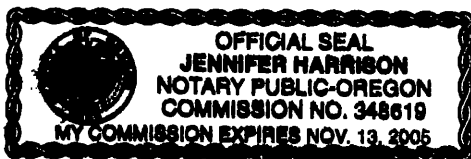
