THIS INDENTURE made this 6th day of February, 2004, by and between Julie Whitlatch, the duly appointed, qualified and acting personal representative of the estate of Mary Lois Rathbone Schilling, deceased, hereinafter called the first party, and Julie Whitlatch, Sharon Bowman and Linda Mickle, as tenants-in-common, hereinafter called the second party;

WITNESSETH:

For value received and the consideration hereinafter stated, the first party has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the second party and second party's heirs, successors and assigns all the estate, right and interest of the estate of the deceased, whether acquired by operation of the law or otherwise, in that certain real property situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Real property, more particularly described as Lot 5, Block 40, HOT SPRINGS ADDITION to the City of Klamath Falls, Oregon, Klamath County, Oregon Tax Account #R306190

Subject to the right of Fermon S. Schilling to occupy and use said property during his lifetime only; upon the conditions set forth in the General Judgment in the matter of the Estate of Mary Lois Rathbone Schilling (Klamath County Circuit Court #02-04001CV) dated January 21, 2004.

TO HAVE AND TO HOLD the same unto the second party and second party's heirs, successors-in-interest and assigns forever.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$0-estate distribution.


