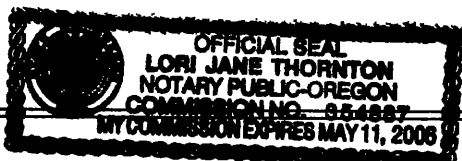

Residential Lots:
