- 1. Grantee, its agents, and invitees shall use said road for ingress and egress to and from Grantee's land only.
- 2. Grantor reserves the right to use and maintain said road for Grantor's own purposes. Grantor may grant use rights to third parties. The parties may cooperate during periods of joint use so that each party's use shall cause a minimum of interference to the other', however, in case of conflict Grantor's right to use shall be dominate.
- 3. Grantee agrees to indemnify and defend Grantor from any loss, claim or liability to Grantor arising in any manner out of Grantee's use of said road. Grantee shall bay Grantor for any merchantable timber or other property of Grantor damaged by Grantee's use of this easement. Grantee assumes all risk arising out its use of said road and Grantor shall have no liability to Grantee or others for any condition existing thereon.
- 4. This easement if granted subject to all other easements and encumbrances of record.
