Interest, late charges and advances for the protection and preservation of the property may accrue after the date of this notice.

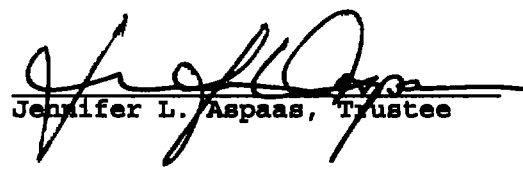

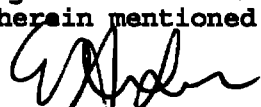
