

AERIAL COMMUNICATIONS LINE RIGHT-OF-WAY EASEMENT

This easement is further described as follows: Facilities to be placed on an existing utility power pole lead as now located across the above described parcel, with said pole lead running in a northerly/southerly fashion and being located along the western boundary of said parcel.

situated in the County of KLAMATH, State of Oregon, together with such additional adjacent area as may be reasonably required by the Company for placement and maintenance of down-guys and anchors supporting the Company's telephone and communications facilities placed hereunder.

It is agreed that the Company, its successors and assigns, shall have access to said premises for the purposes stated, and shall be responsible for any damage to said premises by reason of any negligence on the part of said Company's employees while placing and maintaining construction, provided, however, that the Company shall have the right to clear and keep cleared trees or other obstructions which may interfere or threaten to interfere with the exercise of the Company's rights granted hereunder.
