

AERIAL COMMUNICATIONS LINE RIGHT-OF-WAY EASEMENT

This easement is further described as follows: Easement is for the placement of guy anchors; supporting the existing utility power pole lead, as located outside the right-of-way of Highway 140 on the above described parcel.

situated in the County of KLAMATH, State of Oregon, together with such additional adjacent area as may be reasonably required by the Company for placement and maintenance of down-guys and anchors supporting the Company's telephone and communications facilities placed hereunder.

It is agreed that the Company, its successors and assigns, shall have access to said premises for the purposes stated, and shall be responsible for any damage to said premises by reason of any negligence on the part of said Company's employees while placing and maintaining construction, provided, however, that the Company shall have the right to clear and keep cleared trees or other obstructions which may interfere or threaten to interfere with the exercise of the Company's rights granted hereunder.

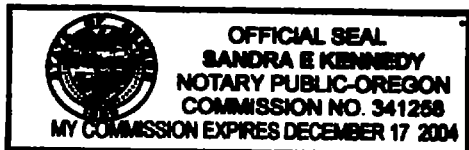
