Whereas, on the 1st day of February, 1982, WEYERHAEUSER COMPANY, a Washington corporation, and LAND USE INVESTMENTS - KLAMATH, a California Limited Partnership entered into an easement exchange, hereinafter called Original Agreement, which was recorded in the records of Klamath County, Oregon on the 22<sup>nd</sup> day of December, 1983, in Volume M83 at page 21966, Deed Records. Said Original Agreement is hereby supplemented as follows:

## WITNESSETH

Weyerhaeuser Company and UST entered into a Timberland Asset Purchase Agreement dated August 30, 1996; and

Whereas, the terms of the Agreement require Weyerhaeuser Company to assign and convey to UST all existing access easements and rights-of-way providing access to the timberlands, which Weyerhaeuser Company has the right to transfer, and

- Whereas, Land Use Investments Klamath transferred all its right, title and interest of Original Agreement to Ken Chilcote; and
- Whereas, on December 22, 2003, U.S. Timberlands Klamath Falls, L.L.C. changed the Company name to Inland Fiber Group, LLC;

NOW THEREFORE IFG and KEN CHILCOTE hereby agree that the location of the easement located in the W1/2NW1/SE1/4, Section 18, Township 28 South, Range 8 East, W.M. as shown in red on the Original Agreement granted by Land Use Investments - Klamath to Weyerhaeuser Company has been relocated approximately as shown in green on the attached Exhibit "A."

It is further agreed that Exhibit "A" of said Original Agreement is hereby deleted and replaced by the Attached Exhibit "A."

Except as herein supplemented all of the terms, conditions and reservations of the Original Agreement shall remain in full force and effect.
