## LEGAL DESCRIPTION:

Beginning at a point on the Southerly side of Front Street; said point described as being South 14°27' East 496.7 feet, and thence South 58°41' East 63.4 feet from the Southeast corner of Lot 92, Block 3, First Addition to Buena Vista Addition to the City of Klamath Falls, Oregon; thence from the point of beginning, herein described South 58°41' East along the Southerly side of Front Street, Buena Vista Addition to the City of Klamath Falls, Oregon, 310.9 feet to a point of angle in Front Street; thence continuing along the Southerly side of Front Street S. 39°31' East 71.5 feet to a point; thence South 45°41' West to the shore of Upper Klamath Lake; thence Northwesterly along said shore to a point situate South 31°19' West of the point of beginning; thence North 31°19' East to the point of beginning, being a portion of Lot 10, Section 30, Township 38 South, Range 9 East of the Willamette Meridian.
