The true and actual consideration for this conveyance is \$30,000.00.

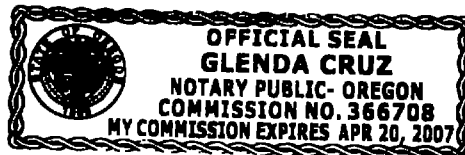
