The undersigned, who is the present beneficiary under said trust deed desires to appoint a new trustee in the place of the original trustee named above;



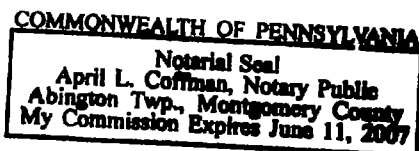
