made so that this deed shall apply equally to corporations and to individuals.

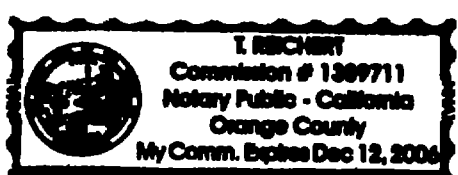
