To Expunge 1-4 Family Rider from Deed of Trust


In all other respects Deed of Trust shall remain unaffected, unchanged and unimpaired by reason of the execution of this agreement.

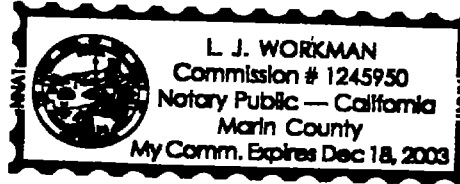

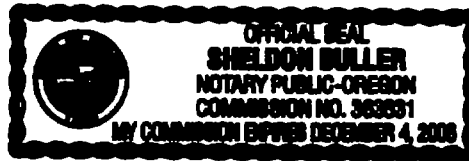
