TRUSTEE'S DEED

THIS INDENTURE, Made this 3rd day of May 2004, between Richard L. Biggs, hereinafter called trustee, and CitiFinancial, Inc., hereinafter called the second party;

RECITALS: Michael Smith and Laura Smith, as grantor, executed and delivered to Aspen Title and Escrow, as trustee, for the benefit of CitiFinancial, Inc., as beneficiary, a certain trust deed dated June 12, 2001, duly recorded on June 14, 2001, in the mortgage records of Klamath County, Oregon, as Volume M01, Page 28318. Copies of the notice of sale were served upon occupants of the property described in the trust deed in the manner in which a summons is served pursuant to ORCP 7D(2) and 7D(3) at least 120 days before the date the property was sold, pursuant to ORS 86.750(1). If the foreclosure proceedings were stayed and released from the stay, copies of an amended notice of sale in the form required by ORS 86.755(6) were mailed by registered or certified mail to the last-known address of those persons listed in ORS 86.740 and 86.750(1) and to the address provided by each person who was present at the time and place set for the sale which was stayed within 30 days after the release from the stay. The trustee published a copy of the notice of sale in a newspaper of general circulation in each county in which the real property is situated once a week for four successive weeks. The last publication of the notice occurred more than twenty days prior to the date of sale. The mailing, service and publication of the notice of sale are shown by affidavits and/or proofs of service duly recorded prior to the date of sale in the county records, those affidavits and proofs, together with the Notice of Default and Election to Sell and the notice of sale, being now referred to and incorporated in and made a part of this deed as if fully set forth herein. The undersigned trustee has no actual notice of any person, other than the persons named in those affidavits and proofs as having or claiming a lien on or interest in the real property, entitled to notice pursuant to ORS 86.740(1)(b) or (1)(c).

The true and actual consideration for this conveyance is \$61,900.00.



The undersigned trustee on May 3, 2004, at the hour of 11:00 a.m., in accord with the standard of time established by ORS 86.755(2) which was the day and hour to which the sale was postponed, and at the place so fixed for sale, in full accordance with the laws of the State of Oregon and pursuant to the powers conferred upon the trustee by the trust deed, sold the real property in one parcel at public auction to the second party for the sum of \$61,900.00, the second party being the highest and best bidder at the sale and that sum being the highest and best bid for the property.
