Klamath County School District, an Oregon School District, Grantor(8) hereby convey and warrant to William L. Garriott III and Dena K. Garriott, Trustees of the Dena K. and William L. Garriott Living Trust, Grantee(s) the following described real property in the County of KLAMATH and State of Oregon, free of encumbrances except as specifically set forth herein:

LEGAL DESCRIPTION

That portion of the SW1/4 SE1/4 of Section 15, Township 39 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon, being more particularly described as follows:

Beginning at a point 75 feet Northerly from and at right angles to the center line of the U.S.R.S. Canal, from which point the quarter corner common to Sections 15 and 22, Township 39 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon, bears South 77° 42' West a distance of 256.4 feet; thence South 0° 35' East a distance of 52.7 feet; thence from said point of beginning North 77° 42' East a distance of 173.8 feet; thence North 63° 50' East a distance of 50.1 feet; thence North 3° 40' West a distance of 307.2 feet to a point in the Southerly right of way line of the Klamath Falls - Lakeview Highway; thence along the Southerly right of way line of the Klamath Falls - Lakeview Highway South 82° 55' West 95.8 feet; thence South 85° 55' West 25.2 feet; North 89° 57' West 26.7 feet; North 85° 22' West 27.3 feet; North 80° 34' West 25.3 feet to a point on the said Southerly right of way line of the Klamath Falls - Lakeview Highway; thence South 3° 40' East a distance of 349.9 feet to the point of beginning.
