property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in

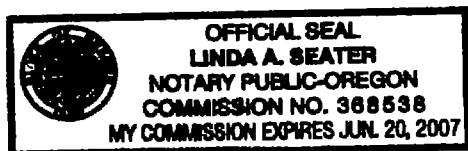
