M01 Page 11249 recorded on 03/21/2001 .

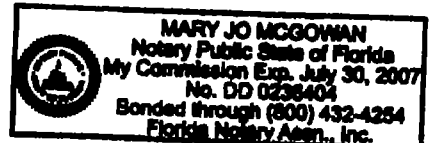

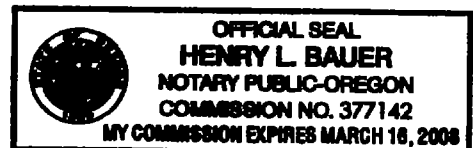
