

MEMORANDUM OF LAND SALE AGREEMENT

KNOW ALL MEN BY THESE PRESENTS, that on May 13, 2004, **Klamath County**, a Political subdivision of the State of Oregon, as vendor and Michael E. In Witness Whereof the said vendor has executed this Memorandum May 19, 2004.

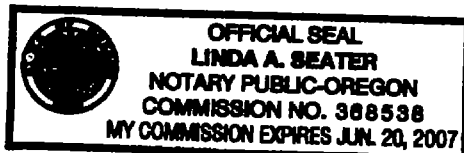
