

MEMORANDUM OF LAND SALE AGREEMENT

KNOW ALL MEN BY THESE PRESENTS, that on May 13, 2004, **Klamath County**, a Political subdivision of the State of Oregon, as vendor and Paul A. The true and actual consideration of the transfer, set forth in said Land Sale Agreement is \$3,400.00, all deferred payments bear interest at the rate of 10% per annum from the date of said Land Sale Agreement until paid.

In Witness Whereof the said vendor has executed this Memorandum May 19, 2004.

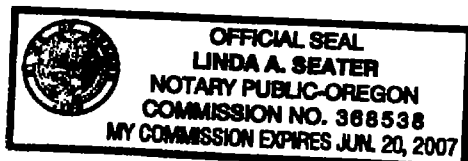
