In Witness Whereof the said vendor has executed this Memorandum May 19, 2004.

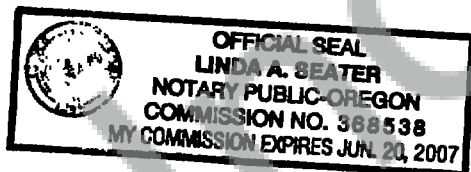
