#### LEGAL DESCRIPTION:

#### Parcel 1:

A portion of the N 1/2 of NE 1/4 of Section 25, Township 39 South, Range 9 East of the Willamette Meridian, in the County of Klamath, State of Oregon, more particularly described as follows:

Beginning at a point on the North right of way line of the County Road which lies South 89°33' West a distance of 1676.3 feet and North 0°27' West a distance of 30 feet from the iron axie which marks the Southeast corner of the NE 1/4 of the NE 1/4 of Section 25, Township 39 South, Range 9 East of the Willamette Meridian, and running thence South 89°33' West along the Northerly right of way line of the County Road a distance of 79 feet to a point; thence North 0°27' West a distance of 276.3 feet to a point; thence South 0°27' East a distance of 276.3 feet more or less to the point of beginning.

### Parcel 2:

A portion of the N 1/2 of the NE 1/4 of Section 25, Township 39 South, Range 9 East of the Williamette Meridian, in the Country of Klamath, State of Oregon, more particularly described as follows:

Beginning at a point on the North right of way line of the County Road which lies South 89°33' West a distance of 1755.3 feet and North 0°27' West a distance of 30 feet from the Iron axie which marks the Southeast corner of the NE 1/4 of the NE 1/4 of Section 25, Township 39 South, Range 9 East of the Willamtte Meridian, and running thence South 89°33' West along the Northerly right of way line of the County Road a distance of 79 feet to a point; thence North 0°27' West a distance of 276.3 feet to a point; thence North 89°33' East a distance of 79 feet to a point; thence South 0°27' East a distance of 276.3 feet, more or less to the point of beginning.

## Parcel 3:

All that portion of the NW 1/4 of the NE 1/4 of Section 25, Township 39 South, Range 9 East of the Williamette Meridian, in the County of Klamath, State of Oregon, more particularly described as follows:

Beginning at a point which lies South 89°33' West a distance of 1676.3 feet and North 0°27' West 306.3 feet from the Iron axie which marks the Southeast corner of the NE 1/4 NE 1/4 of said Section 25; thence South 89° 33' West 158 feet; thence North 0° 27' West 276.3 feet; thence North 89° 33' East 158 feet; thence South 0° 27' East 276.3 feet to the point of beginning.
