TRUST DEED

THIS TRUST DEED, made this 16th day of May, 2004 between Samuel Hunter and Patricia Hunter by Entirety, as Grantor, AmeriTitie, as Trustee, and JELD-WEN, inc., an Oregon Corporation, as Beneficiary, WITNESSETH:

Grantor irrevocably grants, bargains, sells and conveys to Trustee in trust, with power of sale, the property in Klamath County, Oregon, described as: ENDOR NOTATION THE TRUST OF THE PROPERTY OF THE PROPERT appertaining, and the rents, leaves and profits thereof and all fodures now or hereafter attached to or used in connection with said real estate.

The date of maturity of the debt secured by this instrument is the date, stated above, on which the final installment of said note becomes due and payable. In

the event the within described property, or any part thereof, or any interest therein is sold, agreed to be sold, conveyed, assigned or allenated by the grantor without first having obtained the written consent or approval of the beneficiary, then, at the beneficiary's option, all obligations secured by this instrument, irrespective of the maturity dates expressed therein, or herein, shall become immediately due and payable.
