PARKS, husband and wife, Grantor, for the true and actual consideration of \$6,500.00 does convey unto the STATE OF OREGON, by and through its DEPARTMENT OF TRANSPORTATION, Grantee, fee title to the property described as Parcel 1 on Exhibit "A" dated 12/12/2003 attached hereto and by this reference made a part hereof.

Grantor also grants to Grantee, its successors and assigns, a temporary easement for a work area for construction purposes over and across the property described as Parcel 2 on Exhibit "A" dated 12/12/2003 attached hereto and by this reference made a part hereof.

IT IS UNDERSTOOD that the temporary easement rights herein granted shall terminate three (3) years from the date hereof or upon completion of the above-mentioned construction project, whichever is sooner.

IT IS ALSO UNDERSTOOD that the temporary easement herein granted does not convey any right or interest in the above-described Parcel 2, except as stated herein, nor prevent Grantor from the use of said property; provided, however that such use does not interfere with the rights herein granted.

Grantor covenants to and with Grantee, its successors and assigns, that grantor is the owner of said property which is free from encumbrances, except for easements, conditions, and restrictions of record, and will warrant the same from all lawful claims whatsoever, except as stated herein.

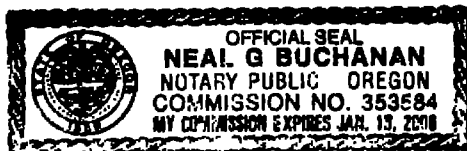

A parcel of land lying in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 1, Township 39 South, Range 8 East, W.M., Klamath County, Oregon; the said parcel being that portion of said SE $\frac{1}{4}$ NE $\frac{1}{4}$ lying between lines at right angles to the "O2" center line at Engineer's Stations "O2" 70+000.000 and "O2" 70+189.585 and included in a strip of land variable in width, lying on the Easterly side of the "O2" center line which center line is described as follows:

Beginning at Engineer's center line Station "O2" 70+000.000, said station being 2458.187 meters North and 390.682 meters West of the Northeast corner of Section 13, Township 39 South, Range 8 East, W.M.; thence North 1° 09' 14" East 160.513 meters; thence on a 70.000 meter radius curve right (the long chord of which bears North 12° 55' 12" East 28.549 meters) 28.751 meters; thence North 24° 41' 12" East 28.224 meters to Engineer's center line Station "O2" 70+217.488.

The width in meters of said strip of land is as follows:

A parcel of land lying in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 1, Township 39 South, Range 8 East, W.M., Klamath County, Oregon; the said parcel being that portion of said SE $\frac{1}{4}$ NE $\frac{1}{4}$ lying between lines at right angles to the "O2" center line at Engineer's Stations "O2" 70+021.000 and "O2" 70+029.000 and included in a strip of land 16.000 meters in width, lying on the Easterly side of the "O2" center line which center line is described in Parcel 1.

EXCEPT therefrom Parcel 1.

This parcel of land contains 37 square meters, more or less.
