NOTICE OF DEFAULT AND ELECTION TO SELL

There is a default by the grantor or other person owing an obligation, the performance of which is secured by said trust deed, or by their successor in interest, with respect to provisions therein which authorize sale in the event of default of such provision; the default for which foreclosure is made is grantor's failure to pay when due the following sums:

Monthly payments in the sum of \$807.13, from March 1, 2004, together with all costs, disbursements, and/or fees incurred or paid by the beneficiary and/or trustee, their employees, agents or assigns.

By reason of said default, the beneficiary has declared all sums owing on the obligation secured by said trust deed immediately due and payable, said sums being the following, to-wit:

Notice is further given that any person named in ORS 86.753 has the right, at any time prior to five days before the date last set for the sale, to have this foreclosure proceeding dismissed and the trust deed reinstated by payment to the beneficiary of the entire amount then due (other than such portion of the principal as would not then be due had no default occurred) and by curing any other default complained of herein that is capable of being cured by tendering the performance required under the obligation or trust deed, and in addition to paying said sums or tendering the performance necessary to cure the default by paying all costs and expenses actually incurred in enforcing the obligation and trust deed, together with trustee's and attorneys fees not exceeding the amounts provided by said ORS 86.753.

EXHIBIT "A"
DESCRIPTION OF PROPERTY

A parcel of land situated in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 11, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at a point marked by an iron pin driven in the ground in the center line of a 60 foot roadway, from which the section corner common to Sections 2, 3, 10 and 11, Township 39 South, Range 9 East of the Willamette Meridian, in the County of Klamath, State of Oregon, bears South $89^{\circ}44' \frac{1}{2}''$ West along the center line of said roadway 611.9 feet to a point in the West boundary of said Section 11 and North $0^{\circ}13' \frac{1}{2}''$ West along the section line 1682.5 feet, more or less; running thence South $0^{\circ}7' \frac{1}{2}''$ East, 331.9 feet, more or less, to a point in the Southerly boundary of said N $\frac{1}{4}$ SW $\frac{1}{4}$ NW $\frac{1}{4}$ Section 11; thence North $89^{\circ}42' \frac{1}{2}''$ East along said boundary line 67.5 feet, more or less; thence North $0^{\circ}7' \frac{1}{2}''$ West 331.85 feet, more or less, to the center line of said roadway; thence South $89^{\circ}44' \frac{1}{2}''$ West along the center line of said roadway 67.5 feet, more or less, to the point of beginning.
