QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon
hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Paul A. Sabesky
hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real
property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath
Klamath County, State of Oregon, described as follows, to-wit:

A portion of Lot 3, Block 11, Klamath Falls Forest Estates, Sycan Unit, also known as Lot 3D, Block 11, being more particularly described
as follows:

Beginning at a point which bears S 35° 57' 32" West 1000 feet and N 54° 02' 28" West 400 feet from the most Easterly corner of Lot 3;
thence N 54° 02' 28" West to a point on the Westerly line of Lot 3; thence S 34° 23' 58" West to the Southwesterly corner of Lot 3;
thence along the Southerly line of Lot 3 to a point which is 35° 57' 32" West from the point of beginning; thence N 35° 57' 32" East to
the point of beginning of Lot 3, Block 11, Klamath Falls Forest Estates, Sycan Unit, according to the official plat thereof on file in the office
of the County Clerk of Klamath County, Oregon.

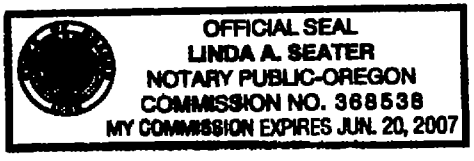
