This agreement is made between the owner/occupants of 6707 and 6719 Airway Drive, Klamath Falls, Oregon. The property described as:

Parcels 1 and 2 of LP 7-97 situated in the SE1/4 of Section 13,
Township 39 South, Range 9, East of the Willamette Meridian,
in the County of Klamath, State of Oregon.

Both owners will equally share any and all expenses in the maintenance and/or repair of the shared well if deemed necessary. The owner/occupant of 6707 Airway Drive will pay the owner/occupant of 6719 Airway Drive \$360.00 annually or \$30.00 monthly for the electrical outage used to power the shared well. This cost was determined at \$.39 per hour, a total of 3 hours usage per day. The annual cost may increase or decrease depending on the fluctuation of power costs, and should be computed accordingly. The owner/occupant of 6719 Airway Drive agrees to keep electricity to the well at all times.

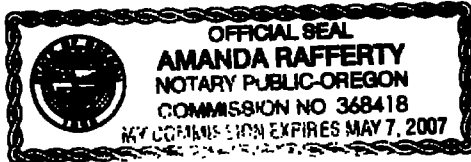
