under Doc # or Book M03 Page 72328 recorded on 09/29/2003 .

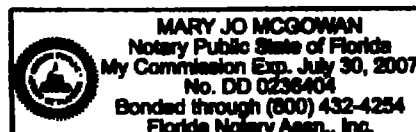
