Note 1. This conveyance transfers the Grantors' interests into her revocable living trust, which is not pursuant to a sale.

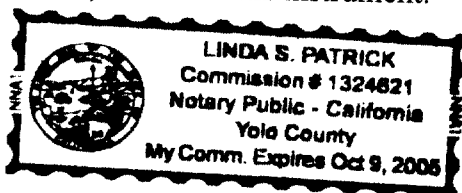


